Budget scenarios for ARCS Site Program:

Background: The ARCS Charter Council has held two budget study sessions to consider the restructure necessary to present a balanced budget to the BOMUSD Board of Trustees. Various scenarios have been discussed. The attached budget proposal incorporates agreements resulting from these study sessions.

Scenario Number 1:

ARCS Site program would remain the same. Assumptions: Tk-8th grade--85 students enrolled--5 certificated teachers--Teaching assistants---Projected deficit 118,000 dollars

Scenario Number 2:

ARCS Site program would change. Assumptions: Tk-8th grade--85 students enrolled--5 certificated teachers--No teaching assistants---Projected deficit 7,000 dollars

Scenario Number 3:

ARCS Site program would change: Assumptions: Tk-6th grade--73 students enrolled--4 certificated teachers--No teaching assistants--Projected deficit 27,000 dollars

Scenario Number 4:

ARCS Site program would change: Assumptions: Tk-8th grade--85 students enrolled--4 certificated teachers--No teaching assistants---Projected Surplus 50,000 dollars

None of the scenarios include a prep period teacher which may cost us approximately 30,000 dollars.
