-David Gleason opens with saying there are many types of Hybrid Schools then asks, what parents would like to see in a hybrid:

-2-3 days a week program

-4-5 days a week

-Core Curriculum taught - the rest taught at home

-Curriculum given by teachers

-Third day of science or Art

-Multi grades in the classroom

-No more than two combined grades

-High School 1 day a week: Study Hall, Science W/Labs

-High School 2 day a week teaching/with assignments given to complete at home

-Not taking away from Homeschool, adding an option

-Co-Op classrooms, were parents are teaching subjects

-Experience of school, controlled setting, any subjects

-Small classroom sizes, making it personable

-Independent Study/Outside Learning ratio is to be considered

-Students attending Hybrid will receive adjusted SF/Possibly no funds

-Daily Curriculum has to be completed for all subjects

-It could be complicated to deliver all subjects on a Hybrid day

-Don't want the program to change for them-Independent Study is preferred

-Using the site; parents and their students, have a Day on the Green, Math Day,

Writing Workshop, Art Day, Science Project
